Dave Gehrtz made a motion to approve the Sheriff's report for the month of September 2021, and it was seconded by Glenda Collier. The motion carried.

Glenda Collier made a motion to approve the Transfer of Funds from County General to Capital Projects in the amount of \$30,000. Dave Gehrtz seconded the motion, and the motion carried.

Dave Gehrtz made a motion to approve the General Journal Entries for the month of September 2021, and it was seconded by Glenda Collier. The motion carried.

OLD BUSINESS:

Todd Weber, Road Superintendent, gave an update on the road department. Maintenance for hire outside the County, the proposed new Sheyenne County shop, delivery of the new motor graders, hiring of a part-time helper to work as needed, and the skid steer lease were among some of the items discussed.

Paul Lies, Sheriff, gave an update on the Sheriff's department. Neal Rud signed the NDDOT Annual Highway Safety Plan. Paul went through some of the questions and items discussed at the City of New Rockford's meeting regarding the Joint Power Agreement with them for Police Protection.

Glenda Collier made a motion to sign the lease with Phyllis and Wayne Topp for the land under the Colvin Township shop. Dave Gehrtz seconded the motion and the motion carried.

The final costs for the basement remodel project were reviewed.

NEW BUSINESS:

The American Rescue Plan Act Revenue Replacement Calculator worksheet was reviewed. The worksheets' calculations show that Eddy County had around \$30,000 in revenue loss for 2020. Other uses for the funds, such as surveillance cameras and improvements to county parks, were discussed.

Glenda Collier made a motion to authorize Patty Williams, Auditor, to request the \$220,000 that Eddy County can receive for this year from the Federal Government Act. Dave Gehrtz seconded the motion, and the motion carried.

A CD is coming due at the Community Credit Union, and the options for reinvestment of the funds were discussed. Dave Gehrtz made a motion to reinvest in a CD at the Credit Union for one year at .35%. Glenda Collier seconded the motion and the motion carried.

Dave Gehrtz made a motion to appoint Tiffany Munson and Glenda Collier to the ND State Fair Association for Eddy County. Neal Rud seconded the motion, and the motion carried.

Glenda Collier made a motion to approve the Eddy County Emergency Operations Plan. Dave Gehrtz seconded the motion, and the motion carried.

Dave Gehrtz made a motion to set the minimum sale prices for the two delinquent tax properties at the total taxes due. Glenda Collier seconded the motion, and the motion carried. The minimum sale price for the former Mill Pump property will remain at \$26,000. The sale will be held at 10:00 A.M. on Tuesday, November 16, 2021.

The members of the hiring committee for the Veterans Services Officer position were discussed. The Commissioners reviewed the five applicants received, and all met the minimum requirements of the job advertisement. All five applicants will be interviewed by the hiring committee.

Kathy Steinbach requested to purchase the old wood cupboard that is in the VSO office for \$25. Dave Gehrtz made a motion to sell her the cupboard for \$25, and it was seconded by Glenda Collier. The motion carried.

Monty Schaefer presented his plans for the Rosefield Dam and discussed the paperwork needed to apply for a permit to own the dam. He will get a bill of sale from the Eddy County Water Resources Board. He requested an easement for flooding in the right-of-way of the county road and a letter of support from the County Commission to include in his application.

The Commissioners went to Devils Lake to tour the Lake Region Law Enforcement Center and the Reentry Center. The tours were led by Rob Johnson, director of both facilities.

Neal Rud, Chairperson, adjourned the meeting at 3:45 P.M.
