There will be an action review for the Genre house fire that occurred on March 13, 2021. This meeting will be held at Ostby Hall in Sheyenne, ND, May 13, 2021 at 7:00 P.M., facilitated by Starr Klemestsrud of Lake Region Law Enforcement Center.

The Commission reviewed the proposed Lake Region Law Enforcement Center Joint Powers Agreement. The Commission and Ashley Lies, States Attorney, did not make any revisions to the agreement at this time.

Dave Gehrtz made a motion to change the Courthouse mask mandate to masks recommended instead of masks required. Glenda Collier seconded the motion and the motion carried.

At 9:00 A.M., the bids for three new motor graders were opened. A bid was received from Butler Machinery Company and from RDO Equipment Company The bids will be reviewed, and a decision will be made at a special meeting to be held on Tuesday, May 11, 2021 at 8:30 A.M.
