Glenda Collier made a motion to approve the Sheriff's report for the month of June 2021, and it was seconded by Dave Gehrtz. The motion carried.

OLD BUSINESS:

Ashley Lies, States Attorney, gave an update. Discussion was held regarding if it is the township's or the Weed Board's responsibility to spray ditches on township roads. Ashley will continue to research and see if she can find clarification on whose responsibility it is.

The employee appreciation picnic will be held on Wednesday, July 21, 2021 at the County shop starting at 4:30 P.M.

The Commissioners reviewed the \$4,000 donation request for 2022 received from Safe Alternatives for Abused Families. No decision on the 2022 donation amount was made. Glenda Collier made a motion to donate \$2,500 to the Safe Alternatives for Abused Families in Devils Lake for 2021. Dave Gehrtz seconded the motion and the motion carried.

Discussion was held regarding the basement remodel and the proposed use of the rooms and furniture needs.

Comparisons of surrounding counties' insurance and retirement benefits were reviewed. Glenda Collier made a motion to increase the share the County pays toward the family insurance premium to 80% starting July of 2021. Dave Gehrtz seconded the motion. Roll call vote: Collier, Gehrtz, and Rud voted aye. Dave Gehrtz made a motion that the County pay 10.26% of the retirement contribution and the

employee pay 5% of the retirement contribution starting January 2022. Glenda Collier seconded the motion. Roll call vote: Gehrtz, Collier, and Rud voted aye.

Kathy Anderson attended the meeting to explain the Treasurer and Superintendent of Schools 2022 budget requests.

Chandy Howard, County Agent, gave an update and explained the County Extension Office 2022 budget request. Who qualifies to be a member to serve on the County Fair Board was discussed. Members must reside in the county.

Todd Weber, Road Superintendent, gave an update and explained the County Road 2022 budget request.

NEW BUSINESS:

Glenda Collier made a motion to increase the GA burial amount to \$2,400 to match what Foster and Wells Counties pay as part of the Central Prairie Human Services Zone. Dave Gehrtz seconded the motion, and the motion carried.
