Merita Aldayel presented the Eddy-New Rockford Public Library annual report for fiscal year ending May 31, 2021. Glenda Collier made a motion to appoint Melanie Homelvig to the Library Board to replace Jennifer Baumbach and to re-appoint Sharron Hope for another 3-year term. Dave Gehrtz seconded the motion and the motion carried.

Tiffany Harr explained the Community Ambulance Service's 2022 budget request and their 2022 projected income. The ambulance service is requesting 5 mills for 2022.

Paul Lies, Sheriff, gave an update and presented his 2022 Sheriff budget request.

Glenda Collier made a motion to increase the City of New Rockford's Joint Powers Agreement for Police Services by 2% for 2022 and the City of Sheyenne's Joint Powers Agreement for Police Services by 1% for 2022. Dave Gehrtz seconded the motion and the motion carried.

Dave Gehrtz made a motion to approve all 2022 preliminary budget requests and to approve the 2022 County preliminary budget for a total of 97.13 mills. Glenda Collier seconded the motion and the motion carried.

Glenda Collier made a motion to set the preliminary budget hearing for 9:00 A.M., Tuesday, September 7, 2021. Dave Gehrtz seconded the motion and the motion carried.

NEW BUSINESS:

Mike Tweed, Eddy County Water Board, dropped off a Garrison Diversion Conservancy District Quick Facts brochure.

Dave Gehrtz made a motion to designate Glenda Collier as the voting delegate for the NDACo annual conference being held at the Bismarck Event Center on October 3-5, 2021. Neal Rud seconded the motion and the motion carried.

Because of the date conflict with the NDACo annual conference, Glenda Collier made a motion to reschedule the October 5, 2021 regular meeting to October 7, 2021. Dave Gehrtz seconded the motion and the motion carried.

Glenda Collier made a motion to approve the Drought Emergency Declaration for Eddy County dated August 3, 2021. Dave Gehrtz seconded the motion and the motion carried.
