SPECIAL MEETING MINUTES

October 28, 2024 8:00 AM
Eddy County Courthouse: Commissioner Meeting Room

The meeting of the Eddy County Zoning Commission was called to order at 8:00 a.m. by Stuart Richter. Members present were: David Allmaras, Levi Rue, Glenda Collier, Bob Hanson, Shauna Laber and Becki Schumacher, County Auditor. Also present were Lisa Thompson, Eddy County Emergency Manager, and Ashley Lies, Eddy County State's Attorney. Members absent were: James Allmaras

Glenda Collier made a motion to approve the agenda as presented. Shauna Laber seconded the motion. All were in favor, motion carried.

Levi Rue made a motion to approve the September 16, 2024 Special Meeting Minutes. Shauna Laber seconded the motion. All were in favor, motion carried.

The meeting opened with discussion on moving the regular quarterly meeting from the first Monday of the first month of each quarter to the second Tuesday of the first month of each quarter.

Glenda Collier made a motion to adopt the Model "D" Floodplain Ordinance as presented. Shauna Laber seconded the motion. Chairperson Richter called for a vote. All were in favor. Motion for recommendation carried.
