Todd Weber, Road Superintendent gave update on Road Department. Equipment is being moved in to the new shop in Sheyenne. The old Sheyenne shop was discussed. Weber would like to continue to utilize the building for storing big equipment, but will consider allowing the City of Sheyenne to also use some of the space for storage. State's Attorney Ashley Lies will look into the legalities of this option.

Roger Langley addressed the Commission on the drainage issue on County Road #4. Langley is looking for a solution so that water does not flood his field. Langley offered to make a donation to Eddy County for the cost of a new culvert, that he proposed be placed next to the existing culvert. Eddy County cannot place another culvert without a stream study. The Commission offered to clean out the cattails, that prevent water from moving, to assist with the drainage. Langley did not think that would help the situation. Langley was encouraged to reach out to the Local DOT in Devils Lake to see if they had ideas or options to assist Langley.

Old Business:

No Old Business was on agenda.

New Business:

Dave Gehrtz made a motion to appoint Glenda Collier as the Commission Chairperson and Dave Gehrtz as the Vice-Chairperson for the 2025 year. Glenda Collier seconded the motion. All were in favor. Motion carried.

The Commissioners reviewed the application from Cenex Pipeline, LLC, as the application was seeking a hardship exception variance to construct a 10' X 10', low roofed, communication building within the 100' setback requirement. The Eddy County Zoning Board approved the recommendation at their November 27, 2024 Special Meeting. Dave Gehrtz made a motion to approve application for variance. Glenda Collier seconded the motion. All were in favor, motion carried.

Glenda Collier made a motion to approve the following Journal Entries: moving \$281.26 from 8374-2909-000 Tuition to 8374-2911-00 Misc., moving \$415.74 from 8417-2923-000 Fed Fish & Wildlife to 8417-2916-000 State Aid and moving \$4,250.00 1000-4211-212 Regular Sheriff Pay to Back the Blue Grant 1000-4118-102. Dave Gehrtz seconded the motion. All were in favor. Motion carried.

With no further business, Chairperson James Allmaras made a motion to adjourn the meeting at 9:35 AM.
